Data Synchronization Implementation Guide 2 STEPS TO BEGIN SYNCING YOUR DATA WITH MCLANE FOODSERVICE

- 1. Make sure all items you sell to McLane Foodservice are 100% barcode compliant.
- 2. If not already a member, join a GDSN data pool such as 1WorldSync
 - a. You can contact 1WorldSync at 866.280.4013 or <u>businessdevelopment@1worldsync.com</u> to get more information
- 3. Load you complete and accurate item data into your GDSN certified data pool and ensure it is ready for publication in production.
 - a. Contact your data pool for any education you might require to complete this step.
- 4. Understand McLane Foodservice's Attribute Requirements
 - a. GS1 Foodservice Phase I and Phase 2 attributes
 - i. McLane Foodservice is utilizing and requesting all GS1 Foodservice Initiative Phase 1 and Phase 2 attributes. For those organizations not currently providing Phase 1 and Phase 2 attributes, McLane Foodservice strongly recommends organizing, loading and sending these attributes via the GDSN at your earliest convenience. At this time, McLane Foodservice will take your data without P2 attributes populated.
 - ii. The GS1 Foodservice Initiative Phase 1 and Phase 2 attributes are located here: <u>http://www.gs1us.org/sectors/foodservice/resource_library</u> 1SYNC customers please refer to the 1SYNC Foodservice Attribute Mapping Guide located on the 1SYNC Solution Center/Foodservice tab/Implementation folder. This Guide will map all the Foodservice Common Names to a 1SYNC
 - attribute and location. b. Additionally, McLane Foodservice is requesting all suppliers to provide below listed attributes:
 - i. minimumOrderQuantity
 - ii. MinimumTradeItemLifespanFromProduction
 - iii. MinimumTradeItemLifespanFromArrival
 - iv. tradeItemTemperatureInformation/minimumTemperature
 - v. tradeItemTemperatureInformation/maximumTemperature
 - vi. additionalTradeItemIdentificationValue
- 5. Complete the McLane Foodservice Trading Partner Form (TPF) located at: <u>http://www.1worldsync.com/web/us/mclane-foodservice</u>.
- 6. McLane Foodservice will create a subscription based on the Information Provider GLN.
- 7. McLane Foodservice will send an email to the supplier's primary data synchronization contact when they are ready for the first publications. An Item List will also be provided along with a request for a sampling of specific items.
- 8. Publish items in production to McLane Foodservice GLN 0048287000016
 - a. Publish as **Initial Load** the sampling of items indicated in the McLane Foodservice email.

- i. A Review CIC will be generated automatically to let you know the item is being reviewed by McLane Foodservice.
- ii. If data discrepancies exist, McLane Foodservice will communicate these via email or phone.
- iii. If minimal data discrepancies exist, McLane Foodservice will instruct the supplier to publish the additional items. This may be a larger selection or the balance of all items. A list of items will be provided.
- b. For New items, publish as Initial Load, only what has been agreed to be purchased by McLane Foodservice.
- 9. McLane Foodservice will provide feedback on publications using the following method:
 - a. RECEIVED: Received but has not yet been reviewed for accuracy
 - b. REVIEW: Data needs to be reviewed by the Data Source
 - c. SYNCHRONIZED: Data recipient has received data they cannot sychronize
- 10. Send ongoing item maintenance notifications through your GDSN Certified Data Pool to McLane Foodservice. Existing items and new items to be published as "Initial Load".
